Fairness

Carl Vinson Institute of UNIVERSITY O

- Review applications and make decisions based on the merits of the issues.
- Support the public's right to know and promote meaningful public involvement.
- Promote equity and equality and treat all people, projects and perspectives equitably.

Compassion

- Recognize board's and government's responsibilities to represent all community members regardless of their socio-economic status.
- Consider exceptions to planning policies when there are unintended consequences or undue burdens.
- Realize that some people are intimidated by the public process and try to make their interactions as stress-free as possible.
- Convey the board's care for and commitment to the members of its community.

Respect for Others

- Focus on the merits in discussions, not personalities, character or motivations.
- · Gain value from diverse opinions and build consensus.
- Be approachable and open-minded.

Responsibility

- Identify ways in which zoning regulations (drafting, public engagement, application, mapping, and enforcement) can be changed to dismantle the barriers that perpetuate the separation of historically disadvantaged and vulnerable communities, and
- Eliminate those zoning and design regulations that disproportionately burdensome on those communities.

- Be truthful with my fellow commissioners, the public and others.
- Be prepared to make unpopular decisions to further the public's interest.
- Credit others' contributions in moving our community's interests forward.
- Excuse myself from decisions when my, or my family's, financial interests may be affected by my agency's actions.

Public Trust

- Remember that planning commissioner's obligation as a public official is to serve the whole community.
- Consider the interests of the entire community in reaching decisions.
- Give full consideration to all aspects of a project, including protection of the environment and the need for affordable housing.
- Promote the efficient use of community resources.
- Balance the fiscal impacts of a project with the government's social and planning goals.

Vision

- Work to ensure that the vision expressed in the plan is one that works to improve the quality of life for all members of the community.
- Be proactive and innovative when setting goals and considering proposals.
- Maintain consistent standards but be sensitive to the need for compromise, thinking outside the box and improving existing systems.
